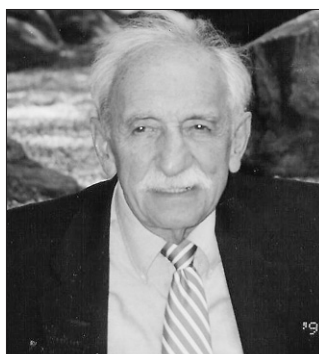

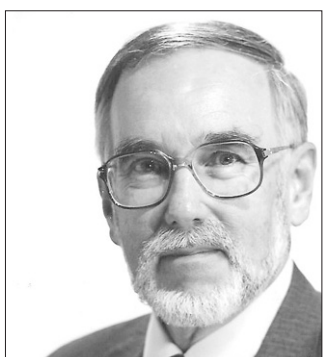
Human Services Dept. budget \$30,000 for essential services for residents in need. And Green's Farms has its share of those residents.

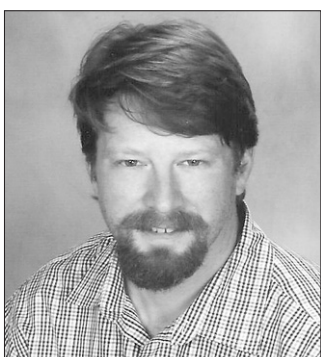
Abatement helps relieve some of the burden, but state law limits such programs to those aged 65 or older. When benefits are improved, the cost must be borne by other taxpayers, including young lower income citizens. Hence the need for balance. In the final analysis, the RTM must make the hard fiscal decisions. As chairman of the RTM Finance Committee, and a member of the Tax Deferral and Abatement Committee, I've had the opportunity to address those issues.

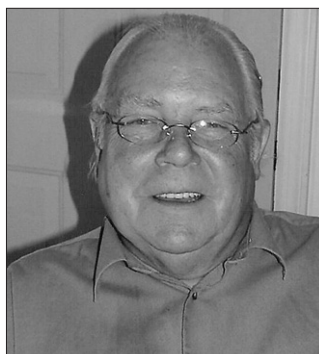

An updated Conservation & Development Plan should preserve open space, while encouraging a centrally located community center - either the YMCA or an appropriate alternative.
